Motion: Vice Mayor Robin Housh made a motion to terminate Town CEO/CFO Lee Jones for cause because of his misrepresentation and possible fraudulent submission of The Town Budget meeting minutes. She stated That Mr. Jones stated that previous Vice Mayor Hamilton was present at the meeting when she was at a doctor's

appointment and that she provided the proof. Vice Mayor Robin Housh also stated that Mr. Jones Botched the 2022 Town Election leaving qualified candidates for office off the ballot leaving a council seat vacant for a year, Mayor Barbara Dansey seconded the motion.

Councilmember Ryan Kornegay asked for Vice Mayor Robin Housh to share some more information on her first cause. Vice Mayor Robin Housh stated that there was an agenda and minutes for this cause. Vice Mayor Robin Housh also stated that she spoke with the auditors, and they explained that Mr. Jones did not supply them with documents in a timely manner and that the ending balance of the accounts has her concerned. Councilmember Brittni Brown spoke on how the audits work and the precure for that and that this is why she stated that things need to be put on the agenda in advance so that they have time to prepare for these things. Councilmember Brittni Brown also stated that terminating Mr. Jones would put The Town in a hard position since they would have to pay Mr. Jones a year salary.

Councilmember Brittni Brown stated that the termination of Edward dean was for multiple reasons, there was no communication between him and the Town Council and that they were not kept in the loop with grants were going on, she stated that he did not communicate that the grants were reimbursable grants and how they work. Councilmember Brittni Brown stated that he has a track record of not doing his job properly. Calvin Malone stated that Edward Dean is a good fit for the interim to pick back up and move forward. Calvin Malone stated that he was not terminated but that he resigned.

Motion: Vice Mayor Robin Housh made a motion to appoint Edward Dean as Interim Town Manager, seconded by Mayor Barbara Dansey.

Councilmember Chiquila Pleas asked why they would want to bring in someone that was terminated from the Town previously for misuse of funds. Councilmember Brittni Brown asked why they would vote to bring in someone they do not have all the proper education on and not knowing the background on why he was terminated.

Councilmember Chiquila Pleas stated that she does not want to see the Town going backwards. Mayor Barbara Dansey stated that she was on the council when the plans for the community center were put in place and that since then the plans have been changed as to what the center is used for. Councilmember Brittni Brown asked Vice Mayor Robin Housh since they have voted to terminate Lee Jones, who would show the Interim the things that need to be done and handled daily. Edward Dean was asked to speak on the interim position, and he explained his standpoint. Edward Dean spoke of the steps he took to make things happen for The Town of Greenville during his previous tenure. The motion has been amended as to put an Interim in place for until January 13th and the position will be advertised and then the council will come back and re-visit the position.
