1. Call to Order: Mayor Brown called the meeting to order at 6:05 PM.
2. Public Comments: Mrs. Nora Jones commented that she would like to question the agenda as could not give a public comment if she did not know what was already discussed and addressed on how they could swear in newly elected officials when we did not have an election due to an error. Mrs. Jones asked why number 12 was on the agenda if it was not being addressed in this council meeting.
 - Mrs. Rosa Richardson starting out by commenting her appreciation to the council members and Town CEO/CFO for allowing the seniors to start using the facilities at the senior building. Mrs. Richardson asked if council and Town CEO/CFO would consider allowing the site manager from Madison to have a key to the senior building. instead of having to come in City Hall to obtain one while they are here. Council Member Livingston stated that he feels like the election should go back to the public. Council Member Malone stated that blame should not be put on one person or persons. Council Member Livingston asked The Town Attorney, John Reid what his legal opinion on handling this matter would be. Town Attorney John Reid stated that in his legal opinion and this specific case that a special election should be held. Mayor Brown stated that pursuant to Town of Greenville Charter, it dictates how a vacant seat is filled. Mayor Brown Stated that the board has discussed the circumstances around the vacancy and there is no fault but that there was an error made that created the vacancy. Mayor Brown stated that there is a constitution that was put in place by the residents of The Town of Greenville, and she is unsure why there is a problem using that constitution to fill the vacant seat. This constitution was voted on and put in place by the Residents of The Town of Greenville in January of 2020. Mayor Brown stated that she would like to follow the Town Charter that is in place.
