- 8. <u>Discuss/Action Resolution for \$300,000 Laon with Capital City Bank to fund costs related to the Feasibility Study. Town CEO/CFO Lee Jones:</u>
  - Town CEO/CFO Lee Jones reported that Honey Lake Clinic is one of our largest employers that we have in the Greenville area and that they would represent our biggest commercial client if we were to get services down there. He reported that the state and The Department of Economic Opportunity applied for funds to do a Feasibility Study to see what it would take to extend our services out there and that this grant is for that and that these are reimbursable but being able to get this loan would help with not having to have the money up front and that these loans are paid back by the grants when funds are received.

- 9. Discuss/Action- Resolution for \$660,000 Loan with Capital City Bank to fund costs related to the Southside Storm Water improvements. **Town CEO/CFO Lee Jones** 
  - Town CEO/CFO Lee Jones reported that he was asked to find resources to help with flooding and that we were awarded funds, a study was performed by engineers that also helped to inform the need for this work. This will deal with a lot of ditches and culverts to help manage the storm water and drains. This is likewise a reimbursable grant so this loan will be paid in full once funding is received. This is everything south of HWY 150 (southside).

    - I. MR. Jones stated that the grocery store project was paused to address some reconstruction and is happy to announce that the project is active again. Mr. Jones stated that the funds expire and had to be completed by the summer.
    - II. Councilmember Malone had a question about the latest engineering changes for the grocery store and Mr. Lee Jones stated that those costs were covered by other agencies and the gap loan.
    - III. Councilmember Malone asked about the overflow for the water and asked to have it explained. Mr. Wayne Malone gave an update along with Mr. Lee Jones.
    - IV. Vice Mayor Hamilton asked about the Senior Center and some concerns as well as Council Member Malone. Mayor Brown spoke on these concerns.

- V. Councilmember Malone asked about the letters that were sent out regarding utility payments and the initial reasoning, Mr. Jones addressed those concerns.
- VI. Councilmember Livingston stated that he has many concerns about the letter and that he feels that it should have been discussed in council before being sent out. Mayor Brown addressed these concerns.
